1.1 Particulars of Organization, Functions & Duties [Section 4(1)(b)(i)]

The International Advanced Research Centre for Powder Metallurgy and New Materials (ARCI), is an autonomous R&D Centre of Department of Science & Technology (DST), Government of India located with its main campus at Balapur, Hyderabad, Telangana State, with two of its off-campus Research Centres of Excellence (CoEs) located at the Indian Institute of Technology, Madras (IITM) Research Park, Chennai and with a liaison office being operated from Gurugram, Haryana.

Mission: To develop unique and techno-commercially viable technologies in the area of advanced materials & processes and subsequently transfer them to Indian industries.

Vision: To be a globally competitive R&D organization in the field of advanced materials and processing technologies.

Objectives:i) Development of High Performance Materials and Processes for Niche Markets.

- ii) Demonstration of Technologies at Prototype and Pilot scale.
- iii) Transfer of ARCI developed technologies to Indian Industry for commercial applications, to be more competitive and competent.
- iv) To impart training to scientific and technical personnel in the field of advanced materials and processes.
- v) To promote Science Outreach Programmes.

ARCI has been setup with a mission to develop unique, novel and techno-commercially viable technologies in the area of advanced materials and subsequently transfer them to Indian industries. A unique feature of ARCI's mandate relates to the fact that it is industry centric. Accordingly, ARCI develops and demonstrates technologies on a sufficiently large scale, not only to prove the reliability/consistency of the technology, but also to carry out effective market sensitization, so that the subsequent transfer of technology to the industry has a greater chance of success. To ensure that multi-disciplinary inputs can be readily harnessed for any of its targeted development efforts, ARCI has formed Centres of Excellence (CoEs) in many generic thrust areas related to materials and materials processing, in the areas of nano materials, engineered coatings, ceramic processing, laser processing of materials, sol-gel coatings, fuel cells, solar energy materials, automotive energy materials. These activities are pursued through Research Centres of Excellence (CoE) namely: Centre for Automotive Energy Materials (CAEM), Centre for Solar Energy Materials (CSEM), Centre for Nano materials (CNM), Centre for Engineered Coatings (CEC), Centre for Advanced Ceramic Materials (CACM), Centre for Laser Processing of Materials (CLPM), Centre for Fuel Cell Technology (CFCT), Centre for Carbon Materials (CCM), Centre for Sol-gel Coatings (CSOL), Centre for Materials Characterization & Testing (CMCT). Each of these CoEs has been involved in the development of advanced materials-based technologies pertaining to their core expertise. A dedicated Centre for Technology Acquisition and Transfer (CTAT) looks after marketing and transfer of technologies developed by the above CoEs of ARCI.

ARCI provides a number of key services like technical support for developing new applications, participation in generation of new markets and up gradation of technology to its technology receivers. "Partnership throughout" is the motto in dealing with the entrepreneurs seeking to commercialize technologies acquired from ARCI. Testing and product characterization, consultancy, training in its areas of core competence are other forms of support extended by ARCI. In addition to the above, ARCI also carries out a fair amount of its job work and limited production, as these have turned out to be crucial in providing important technological impacts to ARCI's technology development efforts. Over the years, ARCI has developed various state-of-the-art technologies employing varied approaches on its own: (a) in collaboration with academic institutions/R&D laboratories within India or abroad, (b)through establishment of a strategic alliance with an industry. ARCI has also explored the concept of establishing jointly operated centres for demonstrating specific technologies of relevance to India in collaboration with organisation.

In addition, ARCI has been undertaking numerous sponsored projects with a variety of government agencies to develop specific products and/or associated technologies, besides carrying out contract research for both foreign and Indian companies. ARCI has also been carrying out basic R&D work, especially in collaboration with renowned institutes/laboratories worldwide. So far, ARCI has successfully transferred/commercialized, technologies/Know-how to about 40 receivers and few technologies are under transfer. ARCI has developed about 250 technological solutions for industrial and strategic sectors.

Management Structure

The Governing Council (GC), consisting of Chairperson, nine members and a Member Secretary who are appointed by the Government of India and a Non-Member Secretary nominated by GC. The Governing Council is the highest executive body of ARCI and carries out the objectives of ARCI as set forth in its Memorandum of Association, Rules & Regulations and Bye-laws. The Director is the executive head of ARCI and he is the Member-Secretary of Governing Council. The Governing Council is assisted by the Technical Advisory Groups (TAGs) and Finance Committee.


ARCI is registered under erstwhile Andhra Pradesh (Telangana areas) Public Societies Registration Act, 1350 Fasli (Act I of 1350 F; Regd. No. 3170 of 1990). The affairs of the Society are managed and administered in accordance with the Memorandum of Association (MoA), Rules and Regulations and Bye-Laws and of the Society as approved by the Government of India.

The Director of ARCI is a Scientist/Technologist of repute having distinguished career in an academic/R&D institution. He is the Chief Executive Officer (CEO) of ARCI. He is assisted by Associate Directors and Heads of various Centres of Excellence and Centres and Senior Admin. & Personnel Officer, Senior Finance & Accounts Officer, Senior Stores & Purchase Officer and Finance & Accounts Officer (Projects).

Organization Structure and Services Offered

ARCI comprises of ten (10) Research Centres of Excellence (CoEs) and each CoE is headed by a Senior Scientist. Head of each CoE reports to the Associate Directors. Each of these CoEs carry out R&D in the core areas of nano materials, engineered coatings, ceramic processing, laser processing of materials, sol-gel coatings, fuel cells, solar energy materials, automotive energy materials and additive manufacturing and materials characterization and testing. Other support Centres are: i) Technology Acquisition and Transfer; ii) Electrical, Electronics and Civil Maintenance; (iii) Information Technology; (v) Technical Information (Library); (vi) Administration & Personnel; (vii) Finance & Accounts; (viii) Stores & Purchase; (ix) Security & Safety (x) Liaison Office, Gurugram.

Genesis and Inception

ARCI became a full-fledged, autonomous R&D Centre of Government of India's Department of Science and Technology (DST), during the year 1997. The seed to the genesis of ARCI, was sown way back in the year 1985-86, when the DRDO's–Defence Metallurgical Research Laboratory (DMRL), under the dynamic leadership of Prof. P. Rama Rao and erstwhile USSR's Belarusian Powder Metallurgy Association (BPMA), under the leadership of Prof. Oleg V. Roman, entered into a research collaboration in the area of Powder Metallurgy. Therefore, the history of ARCI is composed of two distinct periods. The first period spans from 1986 to 1996 during which the Centre was conceived, planned and implemented as an Indo-USSR (CIS) project. From 1997 onwards ARCI witnessed explosive growth to attain the status of a premiere laboratory for development, demonstration and transfer of materials related technologies.

It was due to the vision of Prof. Roman from USSR and Dr. VS Arunachalam, Prof. Rama Rao and Shri SLN Acharyulu from India, that the idea of setting-up a joint research centre for powder metallurgy was first conceived. After further discussions and firming up of the concept, the agreement between India and Soviet Union to set up the centre was signed on March 8, 1988, when the Indian delegation visited USSR. Prof. Rama Rao and Prof. Roman signed the agreement on behalf of India and USSR, respectively. It was also decided that DMRL would establish the project on behalf of DST, given its well-known expertise in the area of powder metallurgy. Consequently, DMRL, under the dynamic leadership of Prof. Rama Rao and Shri Acharyulu, prepared the Detailed Project Report (DPR) and submitted the same to Government of India. The proposal envisaged a contribution of Rs.46.28crores from Indian side towards establishing the centre at Hyderabad and an equal contribution from the Soviet Union in kind, i.e. in the form of equipment's, test facilities and pilot plants. In all, the Soviet Union was expected to supply a total of 177 equipment free of cost. The DPR was put-up to the Government of India by the International Division of DST, under the stewardship of Dr. AP Kulshreshtha and Dr. YP Kumar, for being considered as a project of the Integrated Long Term Program (ILTP) of Indo-Soviet cooperation in science and technology and was approved by Expenditure Finance Committee (EFC) and finally the Cabinet Economic Affairs Committee (CEAC) on May 2, 1990. In fact till today, ARCI remains the most successful and biggest project of ILTP.

Initially, the Advanced Research Centre (ARC) for Powder Metallurgy was registered as a society in erstwhile united state of Andhra Pradesh on October 15, 1990. The first Governing Council (G.C.) of ARC met on November 25, 1990 under the Chairmanship of Dr.VasantGowarikar (then Secretary, DST) and Co-Chairmanship of Dr.Arunachalam (then Scientific Adviser to Raksha Mantri, DRDO). Prof. Rama Rao, then Director of DMRL, and Shri SLN Acharyulu were also members of the first Governing Council. A Steering Committee was also constituted, comprising of Prof. Roman and Prof. Rama Rao and an Advisory Council, which included Dr. AC Raghuram of NAL-Bangalore and Prof. RK Dubey of IIT-Kanpur. The present land (95 acres 22 guntas) on which ARCI has been built was identified soon thereafter and the erstwhile Andhra Pradesh Government in principle agreed to provide the land. A detailed report from Metallurgical Engineering Consultants India Ltd., (MECON) to establish ARC was accepted and recruitment of 25 persons on contract/deputation was approved.

Subsequently, at the 2nd and 3rd Governing Council meetings, the name of ARC was changed to "Indo-Soviet Advanced Research Centre (ARC) for Powder Metallurgy" (20.04.1991) at the instance of the Soviet Union and Prof. Roman was included as a Governing Council Member. In the 4th Governing Council meeting (September 21, 1991), Prof. Rama Rao, who was by then Secretary, DST, took over as Chairman, Governing Council of ARCI. Shri Acharyulu became Project Director (in addition to being Director, DMRL) and Shri G.S. Bhattacharjee became the Chief Project Officer (CPO) and also Member Secretary, Governing Council. Shri S.B. Krishnan started his association with ARC from this G.C. meeting as the new Financial Advisor of DST. The Advisory Council of ARC was expanded to include Dr. CK Gupta and Dr. S. Banerjee both from Bhabha Atomic Research Centre (BARC). At this time, the 95 acres 22 gunthas of land was formally handed over to ARC by the erstwhile Andhra Pradesh Government against a total payment of Rs. 47.80 lakhs towards cost of land. Subsequently, on October 6, 1991, the bhoomi puja was performed on the acquired land.

The 6th Governing Council meeting (held on June 9, 1992) was important, since the Soviet Union had collapsed by then and the Confederation of Independent States (CIS) comprising of independent nations had come into being. The consequences for ARC resulting from the above change were enormous. Though the first lot of 22 free equipment had come by then and the second batch of 43 equipment was ready for dispatch, the CIS side could not pay for the freight of this equipment. Similarly, the CIS countries could not pay the international air fares in respect of their experts who were required to visit ARC to install equipment and facilities. More importantly, many of the equipment originally proposed could not be supplied, since it involved coordination among the CIS countries and this was not possible, given the prevailing political situation. Lastly, even equipment that was available could no longer be provided free of cost as originally agreed and ARC had to pay for such equipment. As a consequence, the contribution of Soviet Union/CIS countries to ARC in kind eventually ended up being to a tune of the order of Rs.25 crores as compared to the Indian contribution of Rs.46.28 crores.

In the meantime, however, preparations for establishing ARC were progressing steadily under the stewardship of Shri Acharyulu and Shri Bhattacharjee. The first batch comprising of 1 regular employee, 21 contract employees, and 2 employees on deputation had been recruited and civil works on the acquired land had commenced. Consequent to Dr.Arunachalam leaving DRDO, Dr. APJ Abdul Kalam took over as Scientific Advisor to Raksha Mantri and thus began his long association with ARC as the Co-Chairman of its Governing Council from its 7th meeting (held on January 26, 1993) onwards. The contract employee strength also continuously increased during the years 1993 and 1994 and reached 93. Meanwhile, during March 1993, the original agreement between India and the former Soviet Union (signed in 1988) was revisited and was replaced by a multilateral agreement between ARC (India) and the Science Academy representatives of all CIS countries, i.e. Russia, Ukraine, Belarus etc. The above agreement signed in 1993 was the first step towards ARC becoming an International Centre. As a result of this agreement, the name of ARC was changed to "International Advanced Research Centre for Powder Metallurgy and New Materials (ARCI)" as it is known today, on March 17, 1994.

The implementation of civil and electrical works progressed in full swing during the years 1993 and 1994. Once the infrastructure for ARCI at its permanent location at Balapur village became nearly ready in May/June 1994, all ARCI personnel, until then stationed in Power Metallurgy (PM) Plant (one of the laboratories) of DMRL, moved to the new ARCI premises. The equipment which had been received from the CIS countries before that time (and mostly kept stored) were installed and commissioned at the new ARCI premises. The already operational detonation spray coating unit was also moved from the MIDHANI shed (a defence PSU) to new ARCI premises.

At this juncture, tragedy struck and quite unexpectedly when Shri Bhattacharjee, Chief Project Officer of ARCI from 1991, passed away on October 22, 1994. The contributions of Shri Bhattacharjee to the establishment of ARCI are indeed immeasurable. It is most appropriate that ARCians always remember him in a more tangible fashion. In his memory, ARCI Seminar Hall was named as "GS Bhattacharjee Seminar Hall".

Subsequent to this event, Dr. G. Sundararajan, Dr. Y.R. Mahajan and Mr.BijoySarma were brought into ARCI at the instance of Prof. Rama Rao and Shri Acharyulu to evolve programmes in the areas of coatings, ceramics and powder metallurgy, respectively. At the 11th Governing Council meeting (on June 3, 1995), the three of them were appointed as Deputy Directors. This Governing Council meeting was also the last one chaired by Prof. Rama Rao. Thus, Prof. Rama Rao was the Chairman of ARCI's Governing Council during the most crucial phase in the evolution of ARCI into a sustainable R&D centre and all ARCians are conscious of his immense contributions.

Prof. VS Ramamurthy assumed charge as Secretary, DST in May 1995 and thus took over as the Chairman of ARCI's Governing Council, with Dr. APJ Abdul Kalam continuing as the Co-Chairman. Prof. Ramamurthy was intimately associated with ARCI for the next 11 years (till May 2006) and his contributions to the establishment of ARCI as a premier materials research and technology development organization are indeed remarkable. ARCI remains eternally grateful to him.

During the first year, after Prof. Ramamurthy took over as the Chairman of ARCI's Governing Council, the following four events occurred which marked the transition of ARCI from a project of DMRL to a full-fledged R & D laboratory of DST.

- The organization of the Indo-CIS 1996 exhibition at ARCI in January 1996. All the CIS countries
 were represented in this exhibition and institutions from all the constituent countries
 participated. This exhibition provided a perfect vehicle to showcase ARCI's technologies as well
 as its connections with the CIS countries to the scientific and industrial community of India and,
 thereby, announce the arrival of ARCI.
- On March 31, 1996, the project phase was officially declared as completed. However, for one
 more year (till March 31, 1997), ARCI remained with ILTP, International Division, DST and, during
 this period, all the remaining/ongoing infrastructural and activities related to the project phase
 were brought to a close. From 1st April 1997, ARCI became a full-fledged autonomous R&D
 laboratory of DST and thus joined the ranks of 16 other autonomous R&D institutes of DST.
- On August 1, 1996 all the contract employees were regularised and placed in regular government pay scales with the service benefits.

 - Thus, the transition of ARCI from the project phase to a full-fledged, independent laboratory occurred through a series of events spread over a whole year, in 1996-1997.
- On January 1, 1997, Dr. G. Sundararajan, an outstanding scientist and academician, was appointed as the first full-time independent Director of ARCI. Under his dedicated and dynamic leadership, until December 2015, ARCI has expanded its areas of R&D tremendously from merely three R&D centres to 10 Research Centres of Excellence with other support centres and human resource development activities have gained momentous growth. ARCI not only gained recognition nationally but also internationally and it has earned a special place for itself among DST Laboratories.
- On January 1, 2016, Dr. G. Padmanabham, took over the charge of Director (In-charge) and later w.e.f. 07.10.2021 he became fulltime Director of ARCI. He was an outstanding scientist and able administrator, under his vibrant leadership, ARCI was making a headway swiftly in all fronts, especially in the areas of new technologies. Suddenly, the destiny struck and untimely he passed away on June 3, 2021 in California, USA leaving behind lots of dreams to be achieved by this vibrant organisation!
- Dr. Tata Narasinga Rao, who was appointed as Director (Additional Charge) looked after the duties and responsibilities of the Director, ARCI from 4th June, 2021 to 24th November, 2022. With effect from 25th November, 2022 Dr. Tata Narasinga Rao was appointed has full time Director of ARCI. Under his able and dynamic leadership, ARCI has not only moved steadily but also made breakthrough in frontier research areas of materials technologies, which were very much in line with the Government of India's "AtmaNibharBharth and "Make in India" Concept and other national mission programmes. Dr. Tata Narasinga Rao has successfully completed his tenure as Director ARCI and he was relinquished as Director, ARCI on 6th May, 2024 (F/N).
- Dr. R. Vijay, a young and visionary senior scientist from ARCI, has been appointed as the Director of ARCI, effective from May 6, 2024. Since taking on this role, he has already begun to implement impactful changes, demonstrating his dynamic leadership and innovative ideas for the organization's future.

The accomplishments of ARCI during the last 28 years, since it became an autonomous, grants-inaid institute of DST has been very well documented in the Annual Reports.

1.2 Powers and Duties of Officers and Employees [Section 4(1)(b)(ii)]

i) Director - Head of the Department

Director is responsible to the Governing Council and to achieve targets and to oversee the smooth functioning of the R&D and other programmes of ARCI. The Director shall see that the provisions of the Memorandum of Association, Rules and Regulations and the Bye-laws including Staff Rules are duly observed. In the case of an emergency, he may take such action as may be necessary and report it to the Chairperson of Governing Council. All other powers of the Director are elaborated in the Rules & Regulations.

All the members of the staff of the Centre shall be under the administrative control and supervision of the Director, who shall issue office orders and necessary instructions from time to time.

ii) Associate Directors

Senior Scientists depending on the functional requirements of the Centre are nominated by the Governing Council as Associate Directors. For smooth functioning and for all administrative purposes, they are the in-charges of a group of Research Centres of Excellences (CoEs) and Support Centres/Centres.

iii) Heads of Centres of Excellence

- (a) Each Centre of Excellence (CoE) or Centre is under a Head (Senior Scientist) who will be an overall in-charge of the CoE or Centre. All the staff of CoE or Centre report to the concerned Head
- (b) All the scientists are attached to each of the Centres of Excellence or Centres. They report to the Heads and carry out Research projects including joint/collaborative and sponsored projects and other related works.
- (c) All the Technical Officers, Technical Assistants and Technicians are attached to each of the Centres of Excellence or Centres. They report to the concerned Head/Scientists/Officers. The Technical Officers along with scientists carry out Research Projects including joint/collaborative and sponsored projects. The Technical Assistants and Technicians assist and provide technical support to the scientists and technical officers in carrying out R&D projects/programmes as well as in operation & maintenance of R&D equipment, instruments and laboratory facilities respectively.

iv) Officers in Administration, Finance & Stores etc.

- (a) One of the Associate Director is the overall head of Administration & Personnel, Finance & Accounts and Stores & Purchase sections.
- (b) Senior Administrative & Personnel Officer (SA&PO) who reports to Associate Director (Admin., Finance & Stores) looks after and carries out duties of the sections of administration & personnel, human resource development, Hindi section, motor transport, dispatch section and ARCI Liaison Office at Gurugram. The staff of above sections report to him.
- (c) Senior Finance & Accounts Officer (SF&AO) who reports to Associate Director (Admin., Finance & Stores) looks after and carries out entire finance & accounts related activities. The staff working in finance and accounts section report to him.
- (d) Senior Stores & Purchase Officer (SS&PO) who reports to Associate Director (Admin., Finance & Stores) looks after and carries entire stores and purchase related activities. The staff working in stores and purchase section report to him.
- (e) Finance & Accounts Officer (Projects) who reports to Associate Director (Admin., Finance & Stores) looks after and carries out entire finance & accounts related activities w.r.t. various sponsored projects. The staff working in finance and accounts (projects) section report to him.
- (f) Staff Officer to Director (SOD) reports to Director. She looks after the management and coordination of works at Director's Office as well as manages the offices of Distinguished ARCI Chair and Distinguished Emeritus Scientist. The staff working in Director's office report to her.
- (g) Security, Fire & Safety Officer (SF&SO) who is the overall in-charge of security, fire and safety aspects of the centre reports to Head/Scientist "G". He is responsible for the development of greenery, maintenance and upkeep of ARCI campus and implementation of various safety precautions and measures in the campus. He is also the Nodal Officer for Special Swatchtha Campaign in ARCI Campus.
- (h) Officers and Assistants are attached to Directors' Office, administration, finance, accounts, stores and purchase sections. They carry out the works as assigned by the concerned officials. The Drivers attached to administration look after the activities of Motor transport section.

1.3 Procedure followed in decision making process [Section 4(1)(b)(iii)]

The Director reports to the Governing Council. Director being head of the Institute is responsible for all the R&D and administrative activities. He is the final approving authority, as per the details given in bye-laws, rules and regulations. Associate Directors, report to the Director. Heads of Centres of Excellence/Centres report to the concerned Associate Directors. Scientists/staff report to the concerned Heads of CoEs/Centres.

1.4 Norms for discharge of functions [Section 4(1)(b)(iv)]

The employees of ARCI shall be governed by the Bye-Laws, Rules and Regulations and Staff Rules. In regard to all matters concerning the service conditions of the regular employees of the Centre, the Fundamental and Supplementary Rules, framed by the Government of India, Staff Rules approved by Department of Science & Technology, Government of India and such other rules and orders issued by the Government of India from time to time shall apply to the extent applicable to the regular employees of ARCI. They shall be further subject to such standing orders and circulars as issued from time to time. Notwithstanding anything contained in the Bye-laws, Rules and Regulations and Staff Rules, the Governing Council shall have the power to relax the requirement of any rule to such an extent and subject to such conditions as it may consider necessary.

The Director, ARCI is assisted by Associate Directors for all scientific and technical related matters. For all administrative, financial and purchase related matters, the Director is assisted by an Associate Director, Senior Administrative & Personnel Officer, Senior Finance & Accounts Officer, Finance & Accounts Officer (Projects) and Senior Stores & Purchase Officer. They shall be responsible for providing support services to all the scientific and technical staff.

The Director shall function under the direct control of the Chairperson, Governing Council/Secretary, Department of Science & Technology, Government of India.

- 1. Every grievance should be dealt in a fair, objective and just manner.
- The Grievance Committee shall meet at least once in a month. However, depending on the number of grievances received and their gravity, the Committee may also meet earlier as and when necessary.
- 3. Cases which are sub- judice/cases which are in courts or any matter concerning judgement given by any court, personal and family disputes, RTI matters, disciplinary and Vigilance matters Or grievances which have already been dealt by Commissions shall not be taken up for redressal by the Committee.
- 4. Any grievance of general applicability or of collective nature or raised collectively by more than one employee OR any grievance against a decision for which there are statutory rules of appeal etc., exists, such grievances shall not be considered by the Committee.
- 5. Any grievances which have already been referred to the Administrative Ministry and decision is pending, such grievances shall not be considered by the Committee.

- 6. The Committee shall not consider grievances which cannot be redressed within the delegated powers of the Director, ARCI.
- 7. Repetition of same grievance again and again shall be dealt separately. The same may be handled and informed to such petitioner with proper facts and justification that repetition of grievance with the same contents are not entertained by the Committee.
- 8. Pseudonymous/anonymous/false complaints may be handled as per the CVC's guidelines.
- 9. Any representation or grievance of an employee should be addressed to his/her immediate reporting officer or Head of Centre of Excellence/Centre/Section.
- 10. In case, if the representation or grievance could not be resolved/addressed by the immediate reporting officer or Head of Centre of Excellence/Centre/Section OR if the employee is not satisfied with the decision communicated to him/her, the same may be submitted/forwarded to the above Committee.
- 11. It has been pointed out by the administrative ministry, that employees of Autonomous Institutes are directly addressing their representations/allegations pertaining to administrative/vigilance matters to the Hon'ble Minister/Office of Hon'ble Minister/higher authorities of the Government etc., without following the proper channel of submission for making such representations. Such instances will be viewed seriously.
- 11a. Without exhausting internal mechanism for redressal of grievances, submission of representations directly to other authorities bypassing the prescribed channel of communication will be viewed seriously and appropriate disciplinary action will taken against those who violate these instructions as it can rightly be treated as an unbecoming conduct attracting the provisions of Rule 3(1)(iii) of the CCS (Conduct Rules), 1964. This would include all forms of communication including through emails or public grievance portal etc.,


